The District Auditions will be held on Saturday, April 8th at ORU. Students play one memorized piece for an adjudicator who will assign a rating and write a critique. Students who earn a I+ or I rating will receive a medal if they bring their critique to the awards desk in the lobby after playing. Students who earn a I+, I or I- may register for the State Achievement Audition, which will be held on May 19th and 20th at OU in Norman. Registration for State must be done at the District Audition, and students must pay the \$25.00 registration fee in cash.

Students who were registered as Merit Division students will qualify to play their Merit piece at State and receive their extra award if they take the theory test and earn a I+ or I rating at District. Merit students who earn a I- at District will automatically be switched to the Solo Division and will play their District piece again at the State Audition. Please note that Merit Division repertoire cannot be changed after March 11th. It is important that the students understand that they are committed to playing that piece at State, if they qualify for the Merit Division.

Theory tests will be given during the District Audition starting at 9:00 a.m. Students should plan on bringing ear buds or headphones and using a cell phone or tablet to stream the aural awareness portion of the test. Some CD players will be available for students who do not have access to a device, but we expect most students to bring their own. Tests should be ready for pick up two to three weeks after the audition, if not sooner. It will depend on how many teachers volunteer to help grade during and after the audition.

Teachers who enter their students will be asked to commit to help at the District Audition for at least a half-day shift. If a teacher is not able to do that, they will pay a \$25.00 District fee. All participating teachers will also be automatically charged a \$25.00 State fee, which will be refunded at the completion of a four-hour work shift at the State Audition.

TAMTA members have already been e-mailed an FAQ document about District Audition and a detailed tutorial about completing the entry form. If you have not received those or would like them sent to you again, please let me know.

#### SUMMARY OF TAMTA BOARD MINUTES

February 3, 2017 at Brookside Library Original minutes by Linda Fields, Recording Secretary

President Kathy Wilson called the meeting to order at 10:10 am. In attendance were: Kathy Wilson, Danny & DeAnna Calhoun, Evelyn Billberg, Linda Fields, Laurie Lightbody, Jan Meyer, Sandy Pierce, Philelle McBrayer, Gloria Johnson and Young-Eun Chung. The minutes of the previous board meeting were approved. Linda thanked everyone for emailing her their reports.

Treasurer Danny Calhoun reported that the Balance in the general fund is \$16,259.35.

Laurie Lightbody, VP for Communications reported that she sent one card to Jan Meyer.

Jan Meyer, VP for Membership thanked everyone for the sympathy cards. She plans to revise and print 200 more TAMTA publicity cards.

Achievement Auditions - Kathy Wilson: She has 12 piano judges and the one string judge; she still needs vocal judge. A District FAQ document was emailed to TAMTA members. The entry form tutorial will be sent out closer to the event date. With the State "duty fee" being collected as part of District registration, teachers who end up with no students entering State are now required to request a refund from Terri Hlubek.

Arrangements – Linda Shade: This month's menu is Spinach Salad with Cranberries, Feta, and

Toasted Almonds w/ Dressings, Bread & Butter, Chicken and Rice Casserole, Brussel Sprouts, Chocolate Covered Strawberries.

Festival – Laurie Lightbody: Net income was \$2,825.97 this year. The decrease from last year is partly due to purchasing more awards with the supply lasting into next year.

Holiday Showcase - Young-Eun Chung: The mall's set up was a problem but the sound system was better this year. In the future we might explore "piggy-backing" with another event in order to have a piano.

Judges – Philelle McBrayer: With the exception of the Spindler-Lynch Competition, we have all the judges needed for the rest of year.

Junior Competition - Margie Berman c/o Kathy Wilson: The OMTA Board voted that consolidation of this event will continue for one more year before final review.

Music Sales - DeAnna Calhoun: Trinity Episcopal is offering us any or all of 15-16 boxes of music from a local teacher's estate. DeAnna plans to pick out only what would sell.

Newsletter - Laurie Lightbody: The deadline is Friday, 2/10, for issue on Monday, 2/13.

Program - Sandy Pierce: Karen Harrington will tell about her experiences developing her successful company, Music Games & Things, and her publishing experience with Hal Leonard.

Senior Competition – DeAnna Calhoun: The entry deadline is next Friday, 2/10.

Sonatina - Gloria Johnson: After discussion, it became obvious that this event needs to be revised

in order to encourage more participation. By the end of April, Gloria will draft a proposal for Board consideration at the May meeting so that the new rules can be included in the Roster.

Website – Laurie Lightbody: The new directory is accessible under Members; the "log in" link will be moved to upper right; all PDF forms are fillable for printing and mailing.

Workshop – Karen Harrington c/o Kathy Wilson: The workshop will be 9a-12:30p (no lunch) on September 23 at ORU's Performance Hall featuring August Antinov. August will perform some of Billy Joel's classical repertoire, and share online enrichment opportunities for teachers.

Young Musicians – Karen Harmon c/o Kathy Wilson: This event was re-scheduled for February 25.

OMTA Board Meeting – Kathy Wilson: Her Adjudication Committee showed their video to the Board. The committee's ratings criteria is now on the OMTA website under Forms Directory/District Achievement. The State Conference schedule was announced; the Guidebook app will replace a hard copy booklet.

Philelle McBrayer moved that we nominate Karen Harrington for MTNA Fellow; the motion passed. Evelyn Billberg will be moving back to Denver next week. We expressed our deep appreciation to Evelyn for all she has brought to TAMTA during her short time here, and wished her well.

Following a motion by Laurie Lightbody, the meeting adjourned at 11:30am.

March 3, 2017, Brookside Library Original minutes by Linda Fields, Recording Secretary

President Kathy Wilson called the meeting to order at 10:10 am. In attendance were: Kathy Wilson, Danny & DeAnna Calhoun, Linda Fields, Laurie Lightbody, Jan Meyer, Sandy Pierce, Philelle McBrayer, Jo Dee Davis and Young-Eun Chung. The minutes of the previous board meeting were approved as corrected. Linda appreciates receiving emailed reports from everyone. Treasurer Danny Calhoun reported that the balance in the general fund is \$16,580.67.

Laurie Lightbody, VP for Communications, reported that she sent out one roster and three cards. One pending new member will receive a roster after their membership is confirmed by MTNA.

Jan Meyer, VP for Membership reported that she would order 200 publicity cards this month.

Achievement Auditions – Kathy Wilson: Almost 400 entries have been received representing 32 teachers; numbers will go higher by Saturday's deadline. Some different rooms are being used this year, with

Joyce Bridgman's input, solving some issues including a crowded alcove and a judge's blocked view of the hands of the students they are judging.

Arrangements – Linda Shade: This month's menu is Caesar salad, bread/butter, baked lasagna, sautéed green beans, vanilla cheesecake, and iced tea.

Judges – Philelle McBrayer: Members are encouraged to send in their feedback about the judges for Senior Competition and Young Musicians.

Newsletter – Laurie Lightbody: This month's newsletter is virtually complete, for issue on 3/6.

Program – Sandy Pierce: All systems are go for Wednesday's program. Gloria is handling the details since the program is a performance by Sonatina Competition winners.

Scholarship / Spindler-Lynch Piano Awards – Jo Dee Davis: All judges are set except strings; no entries have been received yet but piano and vocal are expected. The deadline is 3/8; members can bring entries to the General Meeting. Laurie will include a notice in the newsletter, including Jo Dee's new mailing address.

Senior Competition – DeAnna Calhoun: There were 22 piano entries and 1 flute, with 17 finalists.

Linda Fields worked all day registering students for State, Philelle McBrayer handled the judge's morning meeting and all their paperwork, then graded theory the rest of the day, Sandy Pierce assigned all the monitors' positions, made sure that everyone confirmed, organized all their materials before and after the audition, and handled any little monitor glitches all day. Theory tests, which must be double graded, are in the process of being graded the second time. The grading room got a huge amount of work done the day of the audition - very impressive! Once the tests are graded and the data is entered, the various ribbons and certificates will be attached, and they will be ready for pick up. State Audition schedules will be e-mailed out to participating teachers about two weeks prior to the event. Be sure to read the materials carefully so you know exactly how to handle schedule change requests, and the other aspects of the audition. There was no scholarship activity, except to reimburse General Fund for expenses associated with the Scholarship Auditions. Next year will be Danny's final year as Treasurer. He looks forward to mentoring his successor throughout the 2017-2018 year.

#### SUMMARY OF TAMTA BOARD MINUTES

September 8, 2016 at Brookside Library Original minutes by Linda Fields, Recording Secretary

President Kathy Wilson called the meeting to order at 10:10 am. In attendance were: Kathy Wilson, Jan Meyer, Philelle McBrayer, Danny & DeAnna Calhoun, Laurie Lightbody, Young-Eun Chung, Linda Fields. The minutes of the previous board meeting were approved as read.

Treasurer Danny Calhoun reported that the balance in the general fund is \$14,721.71. In July the e-postcard was filed with the IRS to preserve our non-profit status.

Annual Financial Report: \$4,300 was added to the workshop account from the General Fund's surplus. We can handle ORU's increased fees. The 2<sup>nd</sup> half of the TAMTA memorial scholarship was not paid because the student never requested it.

Summer Months Report: Refunds from OMTA Auditions cleans up the last two years. The Spindler account was effectively zeroed out with a transfer to the General Fund related to Morgan Stanley earnings. Morgan Stanley earnings were distributed among Scholarship funds according to each fund's percentage of total scholarship payments.

Laurie Lightbody, VP for Communications, reported that she is ready to mail rosters. Jan Meyers as VP for Membership has taken over mailing cards; she sent cards to Cynthia Briscoe and Young-Eun Chung.

Jan Meyer, VP for Membership, distributed information cards to board members, and reported that they are having results. Several folks have rejoined.

#### Committee Reports:

Achievement Auditions - Kathy Wilson: Adjustments have been made due to ORU's new policies. With 10 piano rooms and retaining 7 minutes play-
